The Affordable Care Act, Once A GOP Target, Is Now A Midterm Rallying Cry For Democrats

Democrats are centering their campaign to retake Congress and defeat President Trump's Supreme Court pick on a staunch defense of the Affordable Care Act, the landmark health-care law that Republicans used to wipe away their majorities in the past two midterm elections. Democratic candidates and groups are trumpeting support for popular elements of President Barack Obama's signature law and attacking Republicans for trying to rescind them in last year's failed repeal-and-replace effort. Liberal activists also are seeking to convince centrist senators that confirmation of Trump's new Supreme Court nominee, U.S. Appeals Court Judge Brett M. Kavanaugh, would increase the odds that courts would dismantle the law known as Obamacare.
